**4a** (Code ) (Expenses \$ 23,700 including grants of \$ 23,700 ) (Revenue \$ )  
 Work progressed throughout the year on the Strategic Autism Initiative-funded Florida Medicaid database study. The Florida Medicaid system offers a potentially unique insight into the ability to assess healthcare in the United States. The Independent Healthcare Research Database (IHRD) project was initiated to develop a research-ready dataset based upon data generated from the Florida Medicaid system. The IHRD project is conducted under approval by the Liberty Institutional Review Board (IRB). Overall, the IHRD contains over 1.6 billion healthcare records generated from a cohort of over 9 million unique enrolled subjects (about 3% of the U.S. population) from fiscal years 1990 through 2007 (with continuing ongoing data updates). With regard to efforts in 2012 to analyze/assemble the IHRD, in the initial phase, raw data from a few fiscal years from the early 1990s were extracted and built into a prototype cube matrix with a data query interface in Microsoft Excel. These efforts involved generation of extensive computer programming code. The results of the initial phase were successful with regarding to the development of a prototype dataset and interface. Subsequently, efforts were undertaken to use computer programming code developed for the prototype cube matrix, and apply this computer programming code to the original raw data text files for the Florida Medicaid database for fiscal years 1990 through 2007. The aforementioned fiscal years of data for the Florida Medicaid were begun to be loaded into a relational database model with all the computer programming code functional to load this data in its current form. Computer programming code was begun to be generated to undertake the insertion of the population of relational data in the research cube. Efforts were then made to begin the population process of the research cube from the data populated into the relational model, which involved more than 1.6 billion records.

**4b** (Code ) (Expenses \$ 3,847 including grants of \$ ) (Revenue \$ )  
 The Strategic Autism Initiative-funded vaccinated-versus-unvaccinated study progressed insofar as the researchers vaccination data converting and analytic plan. This study will be able to deliver the following information: (1) assessment of how child factors and mother/family factors are associated with child-level outcomes, separately and in a combined manner, and (2) assess whether the child-level outcomes differ between families (mothers) because multi-level approaches will estimate between-mother variance as well as within-mother variance.

 SAI funded analyses of the Vaccine Safety Database (VSD), a database maintained by the CDC for the purposes of examining issues of vaccine safety in population-based epidemiological studies. SAI-funded researchers are the scientists working outside the CDC who have access to this database. SAI-funded studies have looked specifically at exposure-related factors to different vaccines such as age-of-exposure and dose-of exposure. Scientific papers describing the results of these studies have been submitted for publication or are preparation for submission.
